Student Qualifying Criteria

To receive tuition reimbursement under the HOMES grant funding, students must meet all of the following demographic guidelines:

- Students must be one of the following: an incumbent worker, underemployed, unemployed, and/or considered a special population which includes economically disadvantaged, single parent, disabled individual, first generation, veteran, or person of color.
- Students must be at least 16 years of age.
- Students must complete and sign the Northwood Technical College registration form and this form.



Funding

The 3-year, \$9.8 million Housing Opportunity & Mobile Education Solutions (HOMES) project is funded by the Wisconsin Department of Workforce Development. Impact Seven will provide an additional \$20 million for sustainable affordable housing options within the district. Northwood Technical College will provide an additional \$1.25 million to conduct advanced manufacturing training for underemployed, unemployed, and special population individuals.
